Agreement and Undertaking

- 5 Acknowledges and agrees that the Services is eligible for transfer to existing ViewQwest subscribers only if the Transferee is able to accommodate an additional line from ViewQwest at their premises. ViewQwest will not be liable for any additional costs and fees incurred by the Transferee in such an event.
