

Standard Chartered Singapore Marathon x ViewQwest #RunWithVQ Challenge 2024

1 **Definitions and Interpretation**

1.1 Unless the context otherwise requires, the following words and expressions shall have the following meanings in this Contest Terms and Conditions: -

Eligible individuals must be either Singapore citizens or permanent residents. Please note that elites and national championship participants are not eligible to participate in this Contest.

 - (iii) Has the correct Registration ID provided by SCSM 2024 when joining this contest. This registration ID will be the basis for the raffle generation entries.

2.2 Submission Contest

- 2.2.1 This Contest is a campaign in which a Participant must be a registered runner in one of the following race categories: 5KM, 10KM, Half-Marathon, or Full Marathon at the Standard Chartered Singapore Marathon 2024. Additionally, the Participant must have registered with ViewQwest during the "Registration Period." The winners in each race category, who have worn the "Contest" shirt or any red top apparel and posted their pictures on social media using the "Contest" hashtag, are eligible to win prizes.
- 2.2.2 This Registration period shall run from 4 October to 28 November 2024 (the "Registration Period for Contest").
- 2.2.3 This Contest shall run from 29 November to 1 December 2024 (the "Contest Period for Contest").
